CLEANING RECOMMENDATIONS

Use a high-pressure hose (not to exceed 1800 psi) and hot water (max 160 degrees F) to rid the tiles of oils. For best results use a mild soap or detergent like Ivory Liquid with a ph between 4.0 - 9.0, to clean the mats. Do not use steam, degreasers or caustic chemicals. Do not machine wash or mechanically scrub the tiles.
